



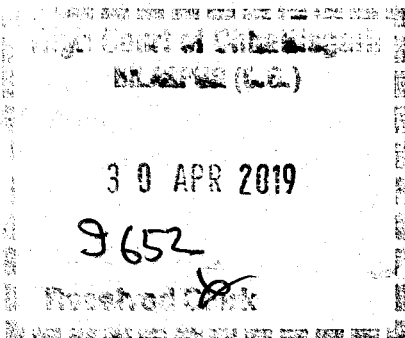

OFFICE MEMORANDUM

Subject: Request for suggestion of panel of retired judicial officers for conducting inquiry of fatal incident of fire at Bhilai Steel Plant on 09.10.2018.

The undersigned is directed to inform that a fire accident happened at Gas Pipe Line of Coke Oven Battery Complex No. 11 of Bhilai Steel Plant (BSP) of Steel Authority of India Limited on 09.10.2018. Consequently, a High Level Committee (HLC) was constituted on 12.10.2018 to investigate the incident and furnish a report. Upon perusal of the 'Independent Investigation Report' of HLC, Hon'ble Steel Minister (HSM) desired that the aspect of 'Criminal Negligence' may also be examined.

2. The matter was discussed with legal experts of SAIL. It was advised that the mandate of criminal proceedings against an individual or group is vested with Police only as the actions for criminal act (action/inaction) against the officials can only be initiated under the provisions of CrPC. However, Ministry of Steel may independently conduct an inquiry to examine the criminal negligence aspect by appointing a committee or by an individual. After conducting the inquiry, Ministry may share the report with police for initiation of action under the provisions of CrPC.

3. The inquiry would help in finding out the aspects of criminal negligence on the part of the plant officials or someone else's part who were involved during the process of design, erection and operation.

4. It is requested that Ministry of Law and Justice may kindly suggest a panel of retired judicial officers for conducting the inquiry in an independent and fair manner.
