3.2 Display Assembly will be replaced only if it founds faulty during installation otherwise it will be returned to Supplier/Vendor and will be excluded from billing. It is Supplier/Vendors responsibility to get Display Assembly return.


3.3 Supplier has to make ensure before supply of the above mentioned items and to check properly both the UPS and provide reports, if other parts of UPS also found faulty then rate for those items may also be included in the quotation if during installation any other parts of UPS found faulty then those will be replaced only after approval of The High Court.

3.4 Price quoted should be inclusive of all applicable taxes and levies.

3.5 The Registrar General reserves the right to change the quantity as per its requirement at any stage.

3.6 The Registrar General reserves the right to place order to supply the Batteries and parts of UPS either of the OEM's irrespective of the rate.

- 3.7 Delivery should be within **one month** from the date of receipt of order for supply.
- 3.8 The supplier has to submit the authorization certificate from the OEM (Original Equipment Manufacturer).
- 3.9 Sealed Quotation should reach on or before date as mentioned above.
- 3.10 The Registrar General, High Court of Chhattisgarh reserves the right to reject any or all Quotations without specifying any reasons thereof.
- 3.11 Payment will be done after successful installation.
- 3.12 All disputes should be within the Jurisdiction of Bilaspur.
- 3.13 No Advance payment shall be made by the High Court.
- 3.14 Warranty & Support: Vendor has to provide at least one year warranty on the items supplied and will provide one year maintenance support for UPS free of cost from the date of installation.
- 3.15 The Vendor has to submit documentary proof of VAT, PAN, Service Tax details and authorization letter /certificate to sell the above mentioned items from OEM.
