AMENDMENT

In the said rules,-

After Chapter 9, the following Chapter shall be inserted, namely:-

"Chapter-9(A)

Faster (Fast and Secure Transmission of Electronic Records) System

183A. Every e-authenticated copy of Judgment/final order/interim order/revision order passed in any other judicial proceedings by the Supreme Court of India, High Court of Chhattisgarh and any other Appellate Court received by Subordinate Court/Trial Court for compliance/execution by FASTER system will have the same effect as they were the original copies of the judgment/order."
