- 4. In Sl. No. 06 of Part-B of Part-III of A.C.R Proforma, the word "Apprising" be replaced with the word "Appraising".
- 5. In Sl. No. 05 of Part-IV of the A.C.R. Proforma, under grading after the words "(Outstanding/Very Good/Good/Average/Below Average)", the letters "(-Å/-B/-C/-D/-E)" shall be suffixed respectively.
