In exercise of the powers conferred by clause (2) of the Article 229 of the Constitution of India, Hon'ble the Chief Justice of the High Court of Chhattisgarh, Bilaspur, makes the following amendment in Chhattisgarh High Court Services (Appointment, Conditions of Service and Conduct) Rules, 2017:-

AMENDMENT

- [1] 1. In Rule 2 Definitions of Part-I General, after Sl.No.(xiii), following shall be inserted :-

"(xiii-a) 'Registrar (OSD) Rules' means the Registrar of the Rules Cell of the High Court.

(xiii-b) 'Registrar (Establishment)' means the Registrar of the Establishment Section of the High Court."

2. In First Schedule (Gazetted Officers), after Sl.No.8, two rows shall be inserted:-
