## Note:-

- O1. When number of cases are connected with each other, the matters shall be listed before the Bench having the Roster to hear the leading/main case. In case, the connected cases are fixed for in different dates, then the connected cases shall be listed on the date, which is earlier.
- 02. All the cases which are already assigned to any of the Single or Division Bench, shall be listed as per Roster if the same is not exception to that Bench.
- 03. In case of Contempt Petitions, if the order has been passed by a Division Bench and one Judge has retired or is no longer in the High Court, then the contempt petition shall be listed before the Bench in which the other Judge is a Member.
- 04. In case, both the Judges who have passed the order are not available, then the contempt petition shall be listed before regular Division Bench.
- 05. In case, the Judge who passed the order is not available, then the contempt petition shall be listed before the regular Single Bench.
- 06. For every Friday of the week **fresh matters** will be listed exclusively leaving all the matters of hearing on Office Note/ I.A./ Motion Hearing in the daily Cause List and after hearing of these cases final hearing matters will be taken up giving priority to the old cases which are more than 5 years.
- 07. A separate monthly list of final hearing old cases which are targeted for disposal in respect of SB-I, SB-II, SB-XI and SB-XII shall be prepared and such cases shall remain in the list till its disposal.
