- All the cases which are already assigned to any of the Single or Division Bench, shall be listed as per Roster if the same is not exception to that Bench.
- In case, the order has been passed by a Division Bench and one Judge has retired or is no longer in the High Court, then the contempt petition shall be listed before the Bench in which the other Judge is a Member.
- 7] In case, both the Judges who passed the order are not available, then the contempt petition shall be listed before regular Division Bench.
- 8] In case, the Judge who passed the order is not available, then the contempt petition shall be listed before the regular Single Bench.

9] Final hearing cases for each Court will be listed Court-wise (Benchwise) without mentioning the names of Hon'ble Judge/Judges who may preside those Benches.
