

In continuation of the instructions published earlier for listing of cases in the Daily and Weekly Cause List, Hon'ble the Chief Justice has been pleased to permit to publish revised instructions for publishing the Daily and Weekly Cause List as per Rules of High Court of Chhattisgarh Rules, 2007, w.e.f 29.11.2021.

INSTRUCTIONS FOR DAILY CAUSE LIST

1. Fresh, I.A.(s) & motion hearing matters shall be published in the Daily Cause List by 04:00 p.m on the day before the date of hearing as per Chart-A & B.

INSTRUCTIONS FOR WEEKLY CAUSE LIST

2. Weekly Cause List (Final Hearing matters) shall be published on Wednesday of the previous week by 01:30 p.m.
3. Not reached cases of Weekly Cause List shall be listed in the Weekly Cause List of the week next to the following week.
4. If in any week Wednesday is a holiday, Weekly Cause List shall be published on the subsequent working day.
5. A supplementary list may be published for urgent matters as per directions of the Hon'ble Benches.

INSTRUCTIONS FOR ADJUSTMENT

6. Learned advocates are requested to file application for adjustments at least 2 working days prior to the date for which adjustment is sought for.
7. Adjustment may not be applied for in respect of cases in which fixed date is given for listing.


