In continuation of Registry Order No. 331/Confdl./2021 dated 03.04.2021, all the Judicial Officers of this State, who have been transferred in the month of March, 2021 and who are in occupation of Government accommodation, shall vacate the same on or before 19.04.2021.

It is also directed that the transferred Judicial Officers, who are required to change headquarters, shall undergo RT-PCR test before joining at their new place of posting and only on production of Negative Test Report, they shall be permitted to join their duties.
