

# HIGH COURT OF CHHATTISGARH, BILASPUR


## ORDER

In view of Covid-19 pandemic, due to imposition of lockdown or declaration of containment zones, the Court working was affected in the financial year 2021-22, as a result of which, in most of the cases, courts could not function for 220 days, which is the number of days on which assessment of the work done by the Judicial Officers in the cadre of Higher Judicial Service and Lower Judicial Service, is made. Hence, the High Court has resolved that the assessment of the work done by the Judicial Officers of the Subordinate Courts will be made with reference to the number of working days as mentioned in column no. 8 of the table at Annexure 'A'.
