

No. 1/3 (1)/2008-E.II (B) of Government of India, Ministry of Finance, Department of Expenditure, dated 1st November, 2021, the State Government, hereby, enhances the Dearness Allowance payable to the Judicial Officers of the State whose pay scale have not been revised on the basis of 7th pay commission recommendations as an interim measure and to pensioner Judicial Officers and to Family Pensioners of late Judicial Officers of the State who are receiving Pension/Family Pension on the basis of Justice Padmanabhan Committee Report, from the existing rate of 189% to 196% with effect from 1st July, 2021.

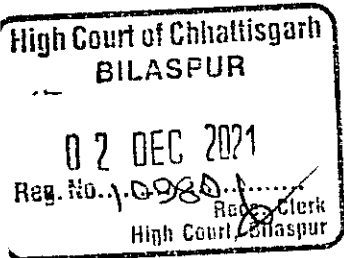
