In exercise of the powers conferred by Article 227 of the Constitution of India read with Section 23 of the Chhattisgarh Civil Courts Act, 1958 (No. 19 of 1958), the High Court of Chhattisgarh with the prior approval of the Governor of Chhattisgarh State, hereby, substitutes sub-rule (2) of Rule 594 of Chapter XXX of the Chhattisgarh Civil Court Rules, 1961 as under:-

"(2) The Lady Judicial Officers of Higher Judicial Service as well as Lower Judicial Service shall wear plain white/cream/grey saree with white blouse or plain white salwar with white kameez, along with black coat, white band and black gown."
