- 1. Tribunal: The Income Tax Appellate Tribunal (ITAT) is an Appellate authority established under section 252 of the Income Tax Act, 1961 to hear various appeals under the Income Tax Act, 1961. The Headquarter of the ITAT is situated at Mumbai and its Benches are situated at various cities in the country.
- 2. Vacancy: Applications are being invited for the post (1) of President, Income Tax Appellate Tribunal (ITAT).
- 3. Qualification:- The qualifications, eligibility, salary and other terms and conditions of the appointment of a candidate will be governed by the provisions of the Tribunals Reforms Act, 2021 and the Tribunal (Conditions of Service) Rules, 2021.
- 4. Procedure for Selection: The Search-Cum-Selection Committee, constituted under the Tribunals Reforms Act, 2021 for recommending names for appointment to the said post, shall scrutinize the applications with respect to suitability of applicants for the post by giving due weightage to qualification and experience of candidates and shortlist candidates for conducting personal interaction.
