

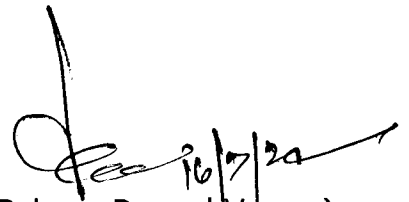

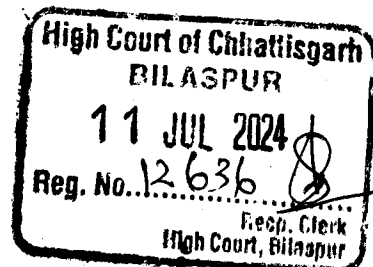

NOTICE

Applications are invited for appointment on the vacant posts of Chairperson, Member (Judicial) and Member (Non-Judicial) of the Haryana Human Rights Commission constituted under The Protection of Human Rights Act, 1993. The eligibility criteria for the above posts are as under :-

I. Chairperson

- (a) **Qualification :-** The Chairperson of HHRC will be a person who has been a Chief Justice or a Judge of a High Court;
- (b) **Term :-** The term of office of the Chairperson shall be three years from the date on which he enters upon his office or until he attains the age of seventy years whichever is earlier. _

II. Member (Judicial)

- (a) **Qualification :-** The Member (Judicial) of the HHRC will be a person who is, or has been, a Judge of a High Court or District Judge in the State with a minimum of seven years experience as District Judge;
- (b) **Term: -** The term of office of the Member (Judicial) shall be three years from the date on which he enters upon his office or until he attains the age of seventy years whichever is earlier.

III. Member (Non-Judicial)

- (a) **Qualification: -** The Member (Non-Judicial) of the HHRC will be a person of having knowledge of or practical experience in matters relating to human rights.
- (b) **Term: -** The term of office of the Member (Non-Judicial) shall be three years from the date on which he enters upon his office or until he attains the age of seventy years whichever is earlier.
- Salary and allowances: -** The salary and allowances and other terms and conditions of service of Chairperson, Member (Judicial) and Member (Non-Judicial) shall be prescribed by the State Government, which shall not be varied to their disadvantage after the appointment.

Willing persons are requested to send their applications to the undersigned alongwith full Bio-data by 21.07.2024. No application will be entertained after the cut-off date. Those who have already applied for these posts in response to Advertisement dated 23.06.2023 and 22.09.2023 need not apply afresh.
