- 4). Single Bench (Special) of Hon'ble Shri Justice Parth Prateem Sahu shall be available from 10:30 AM onwards to hear Miscellaneous Appeals (Compensation) upto the year 2017; all Bail Applications under Section 439 Cr.P.C. (except POCSO matters) registered in the month of February, 2021; all Bail Applications under Section 438 Cr.P.C. except assigned to any Single Bench; Appeals under Section 14A of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 arising out of order of the Special Court under Section 438 Cr.P.C. and tied up matters.
- 5). Single Bench -VIII of Hon'ble Smt. Justice Rajani Dubey shall be available after completion of Division Bench -I to hear all Criminal Appeals upto the year 2008 and tied up matters.
