Invitation for Bids for providing Catering Services At Chhattisgarh State Judicial Academy

- 1. **Chhattisgarh State Judicial Academy under the aegis** of High Court of Chhattisgarh invites tender for providing catering services at Chhattisgarh State Judicial Academy during the training period and workshops.
- 2. Tenderers are requested to submit theirs bids in a sealed envelope at the office of High court of Chhattisgarh, Bilaspur as per detailed specifications and requirements mentioned in this document. Last date of submission of tender 01/12/2022(1st December 2022) at 05:00 PM, Place –Office of Registrar General (Receipt Section), High Court of Chhattisgarh.
- 3. Tenders will be **opened 05/12/2022 at 03:30 PM at the office of Registrar General, High court of Chhattisgarh**, Bilaspur, in presence of entrusted bidders who choose to be present, in any eventuality, on the date and time as decided by the **High court of Chhattisgarh**, Bilaspur. No separate intimation will be given in this regard. The bid should not contain any condition whatsoever and in such condition bid received shall be rejected.
- 4. **High court of Chhattisgarh**, Bilaspur does not bind itself to accept the lower bid. The tenderers shall have to furnish rate analysis for scrutiny of rates by the **High court of Chhattisgarh**, Bilaspur, if required.
- 5. The decision of the **High court of Chhattisgarh**, Bilaspur shall be

final and binding with regard to the bid. All pages of Tender Notice will have to be submitted duly signed and sealed (Muhar)by Bidder with BID as the token to accept to the Terms and Conditions specified in the tender.

- 6. The **High court of Chhattisgarh**, Bilaspur reserves right to accept or reject any/all tenders in part or whole of any bidder without assigning the reasons whatsoever.
- 7. The **High court of Chhattisgarh**, Bilaspur shall reserve the right to change/modify/amend any/all provisions of the tender documents.
- 8. The rate are to be quoted for Breakfast,tea Biscuit,Lunch, Evening Tea-snack and Dinner with detailed description of items to be provided in each Meal.
- 9. The rates to be quoted shall be without taxes. The applicable tax on catering services will be paid by Chhattisgarh State judicial academy to the bidder in addition to the rates quoted.
- 10. The Bidder shall be based at Bilaspur or have a representative establishment Professional Contractor (Proprieter, Firm, Company)
 - 11. The Bidder shall deposite Rs. 50,000/- as Earnest Money Deposite (EMD) by means of **Demand Draft** in the name of **Registrar General, High court of Chhattisgarh**
 - Note Tendor submitted without the prescribed EMD will be rejected & in case of refusal by the catering service provider earnest money will be forfeited.
 - 12. Initially, the period for the catering services issued by this bid will be for 3 years with an increase of 10% every year on the quoted

rate. The tenure may thereafter be extended with mutual consent, subject to satisfactory performance based on the feedback of participants and report of officials of Chhattisgarh State Judicial Academy.

Terms of Payment

- 13. Successful bidders shall be paid for catering charges on the Training Program based after successfully delivering all the services and submission of proper invoice. No advance shall be paid for catering services.
- 14. The catering charges shall be calculated based on actual services provided by the bidder. The charges for providing catering services for participants/guests shall be paid on per head per meal basis.

Eligibility Criteria

- 15. Only those bidders who have minimum experience of 5 years in providing In-house Catering Services to the Government Institutions are to apply for the tenders.
- 16. The Bidder should also have experience to provide Catering Services to a Training Institute before. They are to submit document in this regard.

(Submission of quotation)

- .i. Sealed envelope with the following documents:-
 - Profile of the bidder as per Annexure-2.

- Copy of Pan Card of the bidder.
- Copy of GST certificate.
- ➤ Document regarding Catering Services to a Training Institution before.
- 17. Tender document should be duly filled and signed by the bidder on each page with seal.
- 18. Tender received late on account of any reason whatsoever shall not be entertained.
 - 19. The **High court of Chhattisgarh**, Bilaspur will have option to terminate the bidder after giving a notice of one month in writing without assigning any reason. If the bidder commits breach any of the condition contained in the tender or fails to render services to the satisfaction of the **Chhattisgarh State Judicial Academy**.
- 20. The bidder may terminate the bid by giving two months prior notice in writing.
- 21. Catering services for the participants and guests shall be provided on days during the Training period. Participant means those attending the Training Program at Academy and Guest means the Resource Persons or any other guest authorized to visit the Academy during Training.
- 22. Breakfast, Tea -Biscuit, Lunch, High Tea and Dinner and special breakfast as light refreshment and **bottle of mineral waters** are to be provided as per the Work-Order to the bidder.
- 23. Training Program are conducted throughout the year, but numbers of

participants may vary from time to time. The **Chhattisgarh State Judicial Academy** does not guarantee for minimum numbers of participants. There might be occasions when no training is conducted during the particular period of the month.

- 24. The bidder shall provide adequate numbers of all competent and well trained staff for cooking, cleaning and dinning services.
- 25. Minimum numbers of staff including the Manager/Officer incharge/highly skilled professional/kitchen helper/waiter/dinning helper etc. shall be maintained at any point of time who would manage the requirement of Chhattisgarh State Judicial Academy during training sessions.
- 26. The bidder shall have full control on his/her/their employees and shall give necessary guidelines and instructions to carry out the job assigned to them by the bidder.
- 27. The residential accommodation shall not be provided by the Chhattisgarh State Judicial Academy to the workmen of the bidder.
- 28. The bidder or his/her/their staff shall not use the premises/property etc. of the Chhattisgarh State Judicial Academy for any purpose unless permission is granted by Officials of Chhattisgarh State Judicial Academy.
- 29. It shall be open to officials of Chhattisgarh State Judicial Academy to inspect the kitchen and dinning area at any time.
- 30. The bidder shall bring its own cutlery, utensils etc

(Employees)

- 31. The employees engaged by the bidder shall be trained and experienced people having good health, character; well behaved, obedient and skillful in their tasks.
- 32. The successful bidder shall be asked to furnish list of his/her/their employees to be deployed at Chhattisgarh State Judicial Academy along with their qualifications, experience, address, photos, etc.
- 33. The bidder shall ensure that they observe cleanliness and are properly dressed in clean uniform with hand gloves, head caps & identity cards, during their hours of service.
- 34. The Bidder shall take prior permission from authorized official of Chhattisgarh State Judicial Academy. before deploying any employee at the Chhattisgarh State Judicial Academy. However, Chhattisgarh State Judicial Academy. reserves the right to reject any particular workmen/staff placed employed by the bidder under the bid with Chhattisgarh State Judicial Academy, without assigning any reason.
- 35. The workmen/employees engaged by the bidder shall not have any right/claim over the facilities enjoyed by Chhattisgarh State Judicial Academy staff, participants, etc. It is clearly understood that the bidder's employees shall not have any employee-employer or master-servant relationship with Chhattisgarh State Judicial Academy.

(Disputes Resolution)

36. All disputes arising under this **agreement** shall be settled amicably

through discussions between the parties.

37. In case any unsettled disputes, the same shall be referred to the Arbitrator appointed by **High court of Chhattisgarh**, Bilaspur The provisions of the Arbitration and Conciliation Act, 1996 shall be applicable to such proceedings and the decision of the Arbitrator shall be final and binding on both the parties.

(Service Timings)

38. The timings for serving the Participants/Staff/Guests shall be as under:

- 39. The above timings could be generally observed. However, there could be exceptional circumstances warranting catering service before or beyond the above timing to which the bidder shall oblige.
- 40. The bidder shall supply and serve wholesome and hygienic meals and snack in accordance with the menu as proposed by officials of Chhattisgarh State Judicial Academy.

41. Normally the service is a buffet service. The service of all food items should be **'UNLIMITED'** as per the requirement of the participants/guests from the spread available.

(Preparation of the Menu)

42. Menu for each day's breakfast, lunch, evening snacks and dinner shall be drawn up by the officials of the **Chhattisgarh State Judicial Academy.** The proposed list of items to be kept in the menu as per which the rate is to be quoted by the bidder is attached as **Annexure-III.**
