Terms and Conditions:-

- The Firm will submit its written undertaking for providing warranty of the aforementioned articles, during the warranty period as provided by the OEM for further on year.
- The Firm will submit EMD charge of 10 percent of the quoted amount in round figures in the name of Registrar General, High Court of Chhattisgarh, Bilaspur at the time of submission of quotations, same will be returned to the firm as per the Chhattisgarh Store Purchase Rules 2002.
- The Firm should be established Office/Service Center/Field Engineer at Bilaspur/Raipur of the Chhattisgarh State (Kindly attached the details with quotations like address, Name of the Office/Proprietor with e-mail ID and Mobile Numbers).
- Unit price of article should be including packing, forwarding, freight, insurance, installation, configuration, commissioning, warranty, comprehensive maintenance for one year warranty period or any other charges, in following format:-

- The required quantity of the aforementioned articles may be increased or decreased, depending on the actual requirements.
- The bidder must submit the original installation report along with the bill/invoice for processing the payment.
- The successful bidder shall deliver the articles to the designated location within **07 days** from the issuance of the Purchase Order (extendable by the Hon'ble Committee for Computerization, if required).

In case of delay, a penalty of 0.5% of the cost of the undelivered items will be deducted per week, for up to a maximum of 4 weeks. After that, the matter may be placed before the Hon'ble Committee for Computerization, Weeding, and Digitization of Records of the High Court and District Courts for appropriate action.

- h) Any representation or objection regarding this Tender Notice will be placed before the Hon'ble Committee for Computerization, Weeding, and Digitization of Records of the High Court and District Courts. The decision of the Committee shall be final and binding.
- i) After issuance of the Purchase Order, if the vendor fails to supply the articles to the designated location within the stipulated time, the matter will be placed before the Hon'ble Committee for Computerization, Weeding, and Digitization of Records of the High Court and District Courts for consideration and suitable action, which may include Liquidated Damages or blacklisting of the vendor.
- j) The Registry of the High Court of Chhattisgarh reserves the right to cancel the tender at any time without assigning any reason.

Submission Details

Tender bids must be submitted to the **Registrar General, High Court of Chhattisgarh, Bilaspur**, either in person, through an authorized agent, or by post, **on or before 04:30 PM of 16 / 02/2026**. The bids will be opened on the **next working day, i.e., 17/02/2026 after 12:00 PM**. **Estimates/quotations received via e-mail or after the specified date and time will not be considered**. The Registrar General reserves the right to reject any or all estimates/quotations without assigning any reason.
