Bids will be opened in presence of the bidders/representatives on the same day after expiry of period of bid submission.

#### GENERAL TERMS AND CONDITIONS

- (1) Time for completion of supply and installation is 10 to 15 Working Days from the date of issuance Purchase order with filledup form of the Judicial Officers.
- (2) Bids must be accompanied with EMD of Rs 20,000/- (Rupees Twenty Thousand Only) in the name of Registrar General High Court of Chhattisgarh, Bilaspur (C.G.).
- (3) Rates must be quoted per item/certificate. Rates must be inclusive of taxes for two years validity and also must be quoted the rates for renewal of the DSC for further two years. (As per the attached formate).
- (4) Bidders must attach with the bid the brochure of the products offered by them containing entire description.
- (5) Bidders shall also submit along with the bid a copy of the tender document duly signed and sealed by the bidder as an acknowledgement to the acceptance of the terms and conditions of the tender.
- (6) Validity of rates quoted should not be less than one year.
- (7) Certificates must be Class-2 Certificates with atleast two years validity.
- (8) The certificates must be compatible with the Ubuntu-Linux (14.04, 16.04, 18.04 onwards OS as customized by the eCommittee, Supreme Court of India) as well as with the Windows OS.
- (9) The prices quoted by the Vendor shall be in Indian rupees, inclusive of all taxes and not be subject to any price escalation.

10. The financial bid shall be valid for a period of two years from the date of opening its Financial Bids and High Court may purcahse Digital Signature Signature Certificates for the High Court of Chhattisgarh, and other subordinate Courts of the High Court on the same rates and terms and conditions.

1. Only physical tender documents with financial bids shall be accepted. Tender Documents/Financial Bids through e-mail shall not be entertained. Bids will be opened as per Schedule mentioned in the Tender Document in presence of the

- representatives of the bidders if present.
- 2. The decision of the Committee for Computerization of High Court and Subordinate Courts in the evaluation of the Qualification criteria and Commercial Bids shall be final. No correspondence will be entertained outside the process of negotiation / discussion with the Committee.
  - Note: High Court of Chhattisgarh, Bilaspur may waive any minor informality or non-conformity or irregularity in a Bid.
- 3. High Court of Chhattisgarh, Bilaspur reserves the right to accept or reject any Bid and to annul the Bidding process and reject all bids at any time prior to award of Contract, without thereby incurring any liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders of the grounds for Tendering Authority's action.

#### Payment Terms: -

Payment will be made on receiving successful installation report/testing report of the ordered DSCs at the desired locations. Certificate of successful installation shall be provided by the bidders after obtaing installation report from the District and Subordinate Courts, successful installation and testing report will be provided by the concerning District Judge/Nodal Officer or any authorized Officer by the District & Sessions Judge of the concerned Court.

# Bid Security (EMD – Earnest Money Deposit)

- EMD Rs. 20,000/- (Rupees Twenty Thousand only). Payment can be made through DD/Bank Guarantee valid for three months in each case favouring Registrar General, High Court of Chhattisgarh, Bilaspur (C.G.) payable at Bilaspur.
- 2. Successful bidder will have to submit Performance Security Deposit of 10% of actual value of contract through bank guarantee in favour of Registrar General, High Court of Chhattisgarh, Bilaspur for the period of validity of the DSC.
